BOOKING PROCEDURE

(Please note procedures within the Nursery are very different and Holiday Playscheme bookings must not be made via the Nursery nor Nursery Bookings via the Holiday Playscheme.)

- 1. Please Email to gain a provisional place Your booking is complete once payment has been received. Joining Instructions will be sent after the booking deadline, 26th March and before the first day of the Holiday Playscheme; 6th April. <u>mohairchildcare@hotmail.co.uk</u>
- 2. Please email / send a hard copy of your booking form by 26th March.
- 3. Payment should be sent / received with your Booking Form to secure your place. This should be made by bank transfer or childcare vouchers. We do not accept cash. All Holiday Playscheme Fees must be kept separate from other Mohair Centre transactions, specifically from the Nursery or After School Club.
- 4. Please indicate how payment will be made on the Booking Form or by email, detailing clearly how this will be identified in our Bank Account. Please use your child's surname to ensure that payment is easily tracked and indicate which Voucher Company has been used.
- 5. You will be required to fill in an updated registration form, if you have not attended in the last 6 months.
- 6. Rachel will confirm your booking on receipt of the booking form/email via email, but this is not secure until payment has been made. An email address is essential, please ensure that this is added to the Booking Form.
